Yew 6928)-30% reduction (but lower than 6927 to forma shaped group) and remove all branches overhanging road. Beech (6929)- 20% reduction. This is a mature, established tree of poor shape and form with close proximity to house and overhanging house roof. Reduction to reduce height and vulnerability to winds. Yew (6935)–No change to height but remove branches overhanging road.
